**Refund Rules:** The Schedule of refund of fees will be as follows as per UGC rule October 2018:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	<b>100%</b>	15 days or more <b>before</b> the formally-notified last date of admission
(2)	<b>90%</b>	Less than 15 days <b>before</b> the formally-notified last date of admission.
(3)	<b>80%</b>	15 days or less <b>after</b> the formally-notified last date of admission
(4)	<b>50%</b>	30 days or less, but more than 15 days, <b>after</b> formally-notified last date of admission
(5)	<b>00%</b>	More than 30 days <b>after</b> formally-notified last date of admission

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.

Note: 1) The above refund rules are as per University Grants Commission (UGC) guidelines on Refund of Fees and Non Retention of Original Certificates.
