1. Introduction:

This booklet gives information about the Admission Procedure and Audition Process for **Bachelor of Arts (Honours) (Music - Indian Music) Program – Batch 2025**.

2. Program & Intake & Duration

As per the “New Education Policy”, Bachelor of Arts (Honours) (Music – Indian Music) program is for a duration of 4 years from the Academic Year 2025-2026.

Admission for above-mentioned program is through audition only.

3. Eligibility Criteria (fulfilling all/applicable conditions mandatory)

- 3.1 The candidate must have passed 10+2 or equivalent examination in any stream from a recognized Board and should have obtained a minimum of **50% aggregate marks**. Mathematics **not mandatory** for this program. Students less than 50%, having good potential and skills can be considered as a special case and allowed for audition round.
- 3.2 **Diploma awarded** candidates from International Baccalaureate (IB) Board are considered to 10+2 or equivalence examination with 24 grades/credits compulsory and has passed 3 subjects at Higher Level (HL) and 3 subjects at Standard Level (SL) plus extended essay and TOK
- 3.3 **DP course** candidates from International Baccalaureate (IB) Board are considered to 10 +2 or equivalence examination with 2 subjects at Higher Level (HL) and 2 subjects at Standard Level (SL) OR 3 subjects at Standard Level (SL) and 1 subject at Higher Level (HL)
- 3.4 a. **IBCP equivalence for General Strand** (Arts, Commerce, Science, Law): CP course candidates from International Baccalaureate (IB) Board are considered 2 DP subjects with at least 1 subjects at Higher Level (HL) and minimum 3 points in each DP subject along with Career related studies with at least 03 subjects offered by IB.
- b. **IBCP equivalence for Engineering or Medicine Strand**: CP course candidates from International Baccalaureate (IB) Board are considered 3 DP subjects (Maths, Physics, Chemistry, Biology or other similar subjects) with at least 1 subjects at Higher Level (HL) and minimum 03 points in each DP subject along with Career related studies with at least 03 subjects offered by IB. Further eligibility criteria as stipulated by statutory bodies like AICTE

- 3.5 Candidates of CBSE, ICSE, should mention in the online registration / e-admission form (if selected) 10+2 or equivalent aggregate marks of all the subjects for which the candidate has taken & appeared for (not best of four, five, six or seven). The candidate shall have passed all the subjects taken & appeared for in the applicable examination/s. The aggregate percentage of all subjects for which the candidate has taken & appeared will be taken into consideration for confirming eligibility of the candidate for the program at the time of admission
- 3.6 In case, mark sheet issued by the applicable Board / Institution is in percentile/s, the actual aggregate percentage of all the subjects appeared by the candidate will be taken into consideration.
- 3.7 Candidates above 35 years of age are not eligible to apply
- 3.8 **For IB & Cambridge Candidate :** Candidates who are called for admission on the basis of merit list & if they do not have their 10+2 or equivalent examination mark sheets, will be given "Provisional Admission" based on predicted scores. Fees will be accepted from such candidate but their admission will be confirmed only after the submission of the final mark sheet before the commencement of the program if found eligible. Mark sheet/Transcripts issued by Board/University only be considered (School/Institute will not be accepted).
- 3.9 Submission of AIU equivalence certificate to confirm the eligibility for the program is mandatory for those candidates who have completed their (10+2) examination from Overseas Universities.
- Candidates from Overseas Universities of distance learning must also submit the AIU. If AIU not submitted by the distance learning candidates, then the candidate will be considered as not eligible.
- 3.10 Those candidates who have passed, or, are appearing for 10+2 examination from a Board/University where Grade Point Average is given, such candidates must produce in writing from the Board/University concerned, the equivalent percentage for the GPA /CGPA obtained
- 3.11 Candidate whose final mark sheet is not available at the time of admission is required to upload internet copy/ DG Locker of result duly attested by Principal of the school / college, failing which candidate will not be admitted for the program
- 3.12 Only single mark sheet from single board with all compulsory subjects taken / opted and passed will be considered. Compartmentalized mark sheet will not be considered
- 3.13 Candidate will not be eligible if any subject is marked as ungraded/fail in mark sheet/grade sheet. For absent/ungraded in any of the additional/non mandatory subject will be consider as eligible provided such candidate is declared as pass by respective board

- 3.14 Candidates appearing for their final 10+2 or equivalent examination can also apply provided they must obtain the required minimum cut off marks and also produce the entire necessary Documents, in original, within the given stipulated time
- 3.15 If at any stage, it is found that a candidate does not satisfy the eligibility criteria or the information furnished by him/her in the application form is incorrect, his/her admission to the course, even if selected/ admitted, will stand cancelled and fees will be refunded as per refund rule clauses
- 3.16 Candidates who have cleared their 10 + 2 (12th Standard) by doing a part time course or through distance learning, correspondence course externally, open school from a recognized University are eligible to apply & register as per UGC guidelines
- 3.17 International School/s candidates and those candidates who have completed their (10+2) or equivalent examination/s from overseas school/s / Institute/s / University will have to submit AIU certificate of equivalence (mandatory) to confirm their eligibility for the program as equivalent to (10+2) examination/S
- 3.18 The candidate must have appeared for all his subject(s) / exams before the commencement of the respective program (s) of NMIMS (Deemed to be University). The examination of none of the subjects should be held after the commencement of the respective course.
- 3.19 Candidates whose final mark sheet of the qualified examination is not available at the time of their provisional admission, is required to submit their final marksheet copy as soon as the result declared. In such case, if the candidate fail to meet the required eligibility criteria then his admission will be cancelled and the fees will be refunded as per NMIMS refund rules (even after course commencement).

4. Admission Process

4.1 Online Registration & Payment of Registration Fee

- i. Visit www.nmims.edu for online registration.
- ii. **Online Registration Fee is ₹ 2,000/-** (Please refer details listed in online registration form).
- iii. Registration Fee is non-refundable/ non-transferable.

4.2 Instruction for uploading photo in Registration form;

- Photos should be in .jpeg format, and dimensions should be 200 pixels tall and 150 pixels wide. Size should not exceed 500 kb.
- Photo should have either white or lightly coloured background.
- Eyes should be open and clearly visible.
- Photo should have candidates face distinctly visible, straight and at the center.

- Shoulder tops should be also clear on the photo. Photographs should not be more than 6 months old.
- Photos where candidate is seen to be wearing cap or goggles will be rejected.

4.3 Instruction for uploading the You tube video link in Registration Form :

- The duration of the video should be minimum 2 minutes & maximum 5 minutes. (If exceeds, anything beyond 5 minutes will not be assessed)
- It should be recorded live (without retakes) using camera phone or DSLR with audio capture.
- Any kind of edits or processing (audio or video) is not allowed.
- The video must be uploaded for audition purpose only.
- The video should show the candidate's face clearly and the full instrument sound should be loud and clear.
- The video must be uploaded on YouTube as an "Unlisted" video only. Private videos will **not** be assessed.

4.4 Admit card

- Shortlisted candidates will be invited for the audition round as per important dates.
- You are required to download the admit card from your dashboard.
- No candidate, without admit card or without the photograph on the admit card will be permitted to appear for the audition.
- Candidate must carry/ keep it handy any one requisite original ID proof along with photocopy of the same while appearing for the audition. List of ID proof:
 1. Voters ID
 2. Passport
 3. School/College ID
 4. Aadhaar Card
 5. Driving License (Learner license will not be accepted)
 6. 12th Admit Card
 7. PAN Card

5. Selection Process

- All candidates must login to www.nmims.edu and fill out the application form.

- All candidate has to choose either vocal or sitar option given in the online registration form.
- All eligible candidates who wish to apply for admission to the **Bachelor of Arts (Honours) (Music - Indian Music)** Programme will be required to upload a video of their performance on YouTube (as an Unlisted video) and send the link in the application form.
- The candidates will be then shortlisted and called for the audition on the mentioned date.
- Merit list will be only based on audition process
- Admission offer is given as per merit; waitlisted candidates must check their merit list status regularly and selected candidates should report for the payment of fees within given duration as per important dates.
- Internal / Stream Transfer will be not entertained at any reason.

6. Structure for Audition

- The shortlisted candidates will be invited to the auditions through call letter being published in candidate's dashboard.
- The audition process will include:

Test area	Details	Marks	Weightage
Performance	The candidate can choose any Raga of his/her choice of the level that describes his/her best performing ability. He/She will be assessed on accuracy, technique and knowledge of Raga, Sur and Taal	50	75%
Aural	General musicology and technical knowledge of specialized practical subject (Vocal / Sitar)	25	
Personal Interview	Question will be asked to assess the candidate's aptitude. This will be a non-technical round	25	25%

9. Important instruction

- ◆ **For cancellation/ withdrawal of admission:** Withdrawal / cancellation means voluntary withdrawal / cancellation by candidate for any reason. Candidate has to upload cancellation form duly filled and signed, fees paid receipt copy & cancelled cheque (personal account) to mentioned link :

- Canvassing in any form for admission will disqualify the candidature.
- Candidates will be offered program based on availability of seat, candidate's merit list.
- The XII (12th Standard) examination should have been conducted before the course commencement date.
- All matters of dispute will be subject to the legal jurisdiction of Mumbai only.
- Please see the important dates and preserve it as a guide. All announcements from the institute will be through its website: www.nmims.edu no individual communication will be sent to the candidates. Kindly check website regularly for any update.
- If at any stage, it is found that a candidate does not satisfy the eligibility criteria, or the information furnished by him/her in the application form is incorrect, his/her admission to the course, even if selected, will stand cancelled and fees will be forfeited.
- Candidate's uploaded document will be verified online & if found not eligible at any stage (even after the course commencement) admission will be cancelled and fees will be refunded as per the refund rule clauses.
- Mark sheet/Transcripts issued by Board/University only be considered (School/Institute will not be accepted). Except IB candidates.
- Admission to program is considered as **"Provisional Admission"** till all required and mandatory documents are submitted by the candidate and the same is

verified and approved. If it is found that the candidate is not eligible at any stage (even after the course commencement), admission will be cancelled and fees will be refunded as per refund rule clauses even if selected/ admitted to the program.

- It is the sole responsibility of the candidates to ascertain whether they possess the necessary and requisite qualification for the admission to the courses at NMIMS.
