Refund Rules: The Schedule of refund of fees will be as follows as per UGC rule October 2018:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days or more before the formally-notified last date of admission (on or before 06 th July'2020)
(2)	90%	Less than 15 days before the formally-notified last date of admission. (from 07 th July'2020 to 22 nd July'2020)
(3)	80%	15 days or less after the formally-notified last date of admission (from 23 rd July'2020 to 06 th August'2020)
(4)	50%	30 days or less, but more than 15 days, after formally-notified last date of admission (07 th August 2020 to 21 st August 2020)
(5)	00%	More than 30 days after formally-notified last date of admission (from 22 nd August'2020 onwards)

0In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.

Note: 1) The above refund rules are as per University Grants Commission (UGC) notification on Refund of Fees and Non Retention of Original Certificates of October, 2018 and are subject to revision as per UGC notification (as applicable).
