**Refund Rules:** The Schedule of refund of fees will be as follows as per UGC rule October 2018: If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days or more <b>before</b> the formally-notified last date of admission (on or before 06 <sup>th</sup> July'2020)
(2)	90%	Less than 15 days <b>before</b> the formally-notified last date of admission. (from 07 <sup>th</sup> July'2020 to 22 <sup>nd</sup> July'2020)
(3)	80%	15 days or less <b>after</b> the formally-notified last date of admission (from 23 <sup>rd</sup> July'2020 to 06 <sup>th</sup> August'2020)
(4)	50%	30 days or less, but more than 15 days, <b>after</b> formally-notified last date of admission (07 <sup>th</sup> August 2020 to 21 <sup>st</sup> August 2020)
(5)	00%	More than 30 days <b>after</b> formally-notified last date of admission (from 22 <sup>nd</sup> August'2020 onwards)

OIn case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.
