**Refund Rules:** If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days or more <b>before</b> the formally-notified last date of admission. <b>(on &amp; before 03<sup>rd</sup> August'2023)</b>
(2)	90%	Less than 15 days <b>before</b> the formally-notified last date of admission. <b>(04<sup>th</sup> August – 19<sup>th</sup> August'2023)</b>
(3)	80%	15 days or less <b>after</b> the formally-notified last date of admission. <b>(20<sup>th</sup> August – 03<sup>rd</sup> September'2023)</b>
(4)	50%	30 days or less, but more than 15 days, <b>after</b> formally-notified last date of admission. <b>(04<sup>th</sup> September – 18<sup>th</sup> September'2023)</b>
(5)	00%	More than 30 days <b>after</b> formally-notified last date of admission. <b>(19<sup>th</sup> September'2023 onwards)</b>

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.
